1. Further advice for tomorrow's Hesmond's consultation

The Public Relations company running tomorrow's consultation are unlikely to be really interested in your views. Their job is to get responses that they can use to support the Redrow development. They are likely to ignore negative comments and "milk" any reaction that you give that is positive and use it to support their submission.

We suggest that you make it very clear that you oppose this development and do not want any housing. Say nothing rather than say anything positive about it. Ask your questions and demand answers but try not to engage with their questions.

For example: If they ask "Are you in favour of Affordable Housing for local people?" You may be tempted to say yes. They are likely to use this to say that the community is in favour of the need for housing and this development of 205 homes will provide the much needed 35% of Affordable Homes.

We advise you not to fill in any questionnaire or comment form other than to say no to development.

The Developers Appeal Statement is flawed in its content and arguments:
