New documents have just been added (12/8/20) to this application so it is very much a live application and is likely to come before the Planning Committee soon.

- 1) Amended Illustrative Layout for 26 houses (reduced from 32 to 29 and now 26)
- 2) Amended Tree Removal Plan
- 3) Amended Parking Allocation
- 4) Amended Refuse and Recycling
- 5) Fire Appliance Tracking
- 6) Amended Drainage Strategy
- 7) Letter from Corylus Ecology
- 8) Amended Flood Risk Assessment

Although these additions are an attempt to mitigate the problems that will be encountered on this site, Village Concerns still oppose the principle of development and our objections still stand. Permission has already been granted for 205 houses in this small village. More houses would put totally unacceptable pressure on the village and its resources. It also represents a pincer movement of development at either end of the Village.
